## **Brunner Anliker Limited Warranty**

Food Service Solutions Inc. (FSS) warrants that the equipment, as supplied by FSS and sold within Canada to the original purchaser, is free from defects in materials and workmanship. Should any part thereof become defective as a result of a manufacturing defect within the period and limits defined below, then, at the option of FSS, such parts will be repaired or replaced by FSS or its authorized service agency.

At FSS's discretion, this warranty may be suspended if the invoice for the equipment in question is not paid within 30 days from date of invoice.

Repairs under this warranty are to be performed only by an FSS authorized service company. In all warranty cases the closest FSS authorized service agency (or sub-agent) must be used.

### **Time Period:**

- 2-Year Parts, Labour and Travel Warranty on GSM5, GSM XL and GSM Multicut Food Processing Equipment.
- 5-Year Parts Warranty on GSM5 motor and gear box.

### Exclusions to this warranty:

- Components subject to wear and tear such as cutting and grating discs
- Use of equipment for other than intended use
- Physical damage such as cuts to power cord
- Failure due to improper power connection
- Improper or incorrect use of the appliance and use by untrained or unqualified persons
- Equipment that has not been properly maintained, lack of daily cleaning and water damage to controls
- Equipment use other than intended use, that has not been used in an appropriate manner, or has been subject to misuse or misapplication, neglect, abuse, accident, freight damage, fire, flood, riot or Acts of God

If the equipment is changed, altered, modified or repaired by other than a qualified FSS approved service technician during or after the above limited warranty period, then FSS and its supplier shall not be liable for any damages to any person or to any property which may result from the use of the equipment thereafter.

Warranty does not cover services performed at overtime or premium labour rates. FSS does not assume any liability for extended delays in replacing or repairing any items in the equipment beyond the control of FSS. FSS shall not be liable for consequential or special damages of any nature that may arise in connection with such product or part.

Warranty only covers equipment sold by FSS and sold within Canada. There will be no coverage for equipment located outside of Canada, or any island not connected by roadway to the mainland, unless an FSS authorized service agency or sub-agent is located on said island.

Chef assistance contemplated in the terms and conditions and any other materials prepared by FSS are subject to additional charges and may be denied altogether by FSS if the equipment is located more than 150 km from the offices of FSS or an authorized agency of FSS.

The foregoing warranty is in lieu of any and all other warranties expressed or implied including any implied warranty of merchantability or fitness and constitutes the entire liability of FSS. In no event does this warranty extend beyond the duration of the above time periods.
